

Library & Archives NT Strategic Plan 2019-2023

Context

Library & Archives NT (LANT) is a branch of the Department of Tourism, Sport and Culture, created in September 2019 by bringing together the Northern Territory Library and the Northern Territory Archives Service. This Strategic Plan sits within the Department's broader strategic planning framework.

LANT has four main responsibilities:

- Under the *Information Act* Part 9 we appraise, collect, transfer and preserve archives and permanent records; provide access to Territory Archives; maintain a register of records retention and disposal schedules; prepare, promote and monitor compliance with archives standards; and provide advice (including training) to enable compliance with archives standards to public sector organisations.
- Under the *Publications (Legal Deposit)* Act and through our connections with the community we collect, preserve and share the documentary heritage of the Northern Territory.
- In partnership with local governments we develop public library services to meet the needs of the Territory's diverse communities. Connected Communities: Vision for Northern Territory Public Libraries 2017-2023 sets a strategic direction for LANT's engagement with public libraries and the services we deliver to achieve this are documented in the Public Library Funding Agreement 2018-2023.
- We provide a Parliamentary Library Service to Members and staff of the Legislative Assembly of the Northern Territory through a Memorandum of Understanding.

We provide services to the public through the NT Library at Parliament House; the NT Archives Centre in Millner; at Hartley St Alice Springs; and through a range of online channels.

We work in close collaboration with professional networks such as National and State Libraries Australia (NSLA), Council of Australasian Archives and Records Authorities (CAARA), the Australian Library and Information Association (ALIA) and Australian Society of Archivists (ASA).

4. Digital transformation

Transform delivery of digital library and archives services to meet statutory obligations and clients' needs through innovative people, policies, processes and platforms.

5. Capable organisation

Build our organisational and individual capability to deliver quality library and archives services for now and into the future.
